Transportation Agreement

This Agreement made at Velneshwar on this 27th day of September, 2016

BY AND BETWEEN

VPM's Maharshi Parshuram College of Engineering a Engineering College and having its registered office at Hedvi Guhaghar Road,At: Velneshwar,Taluka: Guhaghar,District: Ratnagiri,Maharashtra 415729 (hereinafter referred to as "MPCOE" which expression shall, unless repugnant to the meaning or context thereof, mean and include its successors in interest and permitted assigns) of the one part;

M/s RENUKA BUS SERVICE, a firm registered under the Bombay Shops and Establishments Act, 1948 and having its registered office at Flat No.17,Shree Raj Hill View,Sr. No.77/2/14,Near Ved Bhavan,Off.Paud Road, Pune – 411038 And having Branch Office at House No. 244, At. Post Wadad, Taluka – Guhagar, District - Ratnagiri (hereinafter referred to as "Contractor", which expression shall, unless repugnant to the meaning or context thereof, mean and include its successors in interest and permitted assigns) of the other part;

(Hereinafter "MPCOE", and "Contractor", individually referred to as "Party" and collectively referred to as "Parties")

WHEREAS Maharshi Parshuram College of Engineering a Engineering College located at Valneshwar.

AND WHEREAS , Contractor, is engaged in the business of providing transport services to factories ,Schools ,Colleges and corporates.

AND WHEREAS MPCOE is desirous of providing transport facilities to its Students and Faculties.

AND WHEREAS MPCOE agreed to assign this contract to Contractor to provide such STUDENT/FACULTY transportation services and Contractor expressed its willingness to act as transport provider on the terms and conditions hereinafter appearing.

AND WHEREAS this agreement came into force w.e.f. 01st June ,2016.

NOW THEREFORE, in consideration of the promises and mutual agreements, covenants and conditions set forth herein, it is hereby agreed by and between the Parties as follows:

Article 1: Appointment

Maharshi Parshuram College of Engineering, hereby appoint M/s Renuka Bus Service as a Transport Service Provider; to provide transport services to its Students/Faculties and M/s Renuka Bus Service hereby accepts such appointment, on the terms and conditions herein contained.

Article 2: Scope of work

- **2.1** M/s Renuka Bus Service agrees and undertakes to make available Two buses for transportation of the Students/Faculties.(Number of Buses may be increased and conveyed to Contractor from time to time)
- 2.2 Contractor shall employ at its cost / expenses, necessary personnel as may be felt necessary by Contractor to carry out the services under this agreement. MPCOE shall not be responsible for any salary, bonus or other payments due to such people employed by Contractor.
- 2.3 There will exist no relationship of employer-employee between MPCOE and the Contractor

Article 3: Representations

- 3.1 Contractor represents that the vehicle made available by Contractor will be roadworthy and in running and mechanically fit condition and will hold valid Road permit, RTO Registration, pollution certificate, necessary Insurance and any other Approvals / Licenses of the appropriate authorities to run such transportation facility, in respect thereof.
- 3.2 Contractor represents that it shall obtain and maintain all licenses and approvals required to be obtained by it to act as a transporter of persons in Ratnagiri, as contemplated under this Agreement.

Article 4: Service fee and conditions

- **4.1** In consideration of Contractor providing transport services to MPCOE students, MPCOE students shall pay to Contractor an amount of
 - A) Rs 3,000/- per month per Student /Faculty From Chiplun to Velneshwar
 - B) Rs 1800/- per month per Student /Faculty From Chikhali to Velneshwar
 - C) Rs 2000/- per month per Student /Faculty From Marg Tamahane to Velneshwar
 - D) Rs 3,000/- per month per Student /Faculty From Shringar Tali to Velneshwar
 - E) Rs. 2600/- per month per Student /Faculty From Thabi to Velneshwar
 - F) Rs. 2400/- per month per Student /Faculty From Rampur to College
 - G) Rs. 2200/- per month per Student /Faculty From Ghonsare to Velneshwar

This bus service is full time for MPCOE College only.

The Kilometers shall be counted from Contactor's Garage to Garage The said amount shall be inclusive of RTO permits of vehicles, insurance, driver salary, fuel and other such charges.

- **4.2** Any new government regulations resulting in increase / decrease of the cost of RTO permit and insurance will be added / subtracted, respectively, to the existing rate with effect from the date of implementation and the monthly transport charges shall also stand revised accordingly.
- **4.3** Payment should be paid till 10th of every month to the contractor.

Article 5: Term of this Agreement

The Agreement between MPCOE and Contractor is effective from 01st June ,2016. The agreement shall remain in full force for a period of Four Years with Lock in and shall expire automatically upon the expiry of the said period i. e. on 31st May,2020 unless extended for another period of Two Years. Either party is free to withdraw from this agreement by giving three months notice. Further this agreement shall be renewable at the end of the current term for a successive mutually decided term unless either party renewable at the end of the current term for a successive mutually decided term unless either party gives three months notice of its intention not to renew before expiration of the current term.

IN WITNESS WHEREOF, the Parties hereto have through their respective duly authorized representatives executed this Agreement in two originals, the day and the year first hereinabove written.
